

DECISION OF THE CHAIRMAN OF THE BOARD OF APPEAL OF THE EUROPEAN CHEMICALS AGENCY

(Withdrawal of the appeal by the Appellant – Closure of the proceedings)

THE CHAIRMAN OF THE BOARD OF APPEAL

gives the following

Decision

- 1. On 3 February 2023, the Agency issued an invoice to the Appellant for its application for the approval of the active substance peanut butter under Article 7(2) of the Biocidal Products Regulation, and the Fee Regulation. By that invoice, the Agency required the Appellant to pay the full amount of the relevant fee (EUR 120 000) instead of the reduced fee for small or medium enterprises (EUR 72 000).
- 2. On 4 May 2023, the Appellant filed the present appeal seeking the partial annulment of the Contested Decision and the refund, by the Agency, of the amount levied in excess (EUR 48 000).
- 3. On 4 September 2023, the Agency filed its defence.
- 4. On 6 November 2023, the Appellant withdrew its appeal.
- 5. Under Article 1b of the Rules of Procedure,³ the Chairman closes the proceedings if an appeal is withdrawn.
- 6. Pursuant to Article 4(4) of the Fee Regulation, the fee levied for submission of an appeal shall be refunded if the Executive Director of the Agency rectifies a decision or if the appeal is decided in favour of the Appellant. Since neither of these alternatives apply in the present case, the appeal fee is not refunded.

On those grounds,

THE CHAIRMAN OF THE BOARD OF APPEAL

hereby:

- 1. Closes Case A-005-2023.
- 2. Decides that the appeal fee is not refunded.
