- Pull the upper part of the cover upwards. Hang or place the trap ideally in a warm and sunny place.
- After 3 weeks of use (the color of the mixture fades),if needed, fill with a new attractant mixture.
- Level of water within the trap needs to be check regularly to maintain efficacy of the product. Make sure that the trap does not dry out.
