I. Summary record of the proceedings

Item 1 – Welcome and introduction

1.1 Welcome and opening by the Head of Unit of ECHA Support and Enforcement

The Head of Unit of ECHA Support and Enforcement chaired the meeting before the election of the Forum Chair (Item 2) and welcomed all the participants to the first remote plenary meeting of the Forum. He announced that Lithuania was nominated as the proxy for Latvia.

He informed that the quorum requirement was met.

1.2 Practicalities of a remote meeting

The meeting participants were reminded of the main features of the tool used to run the remote meeting.

1.3 Adoption of the agenda

The meeting chair indicated the changes in the agenda (Content IV, $\underline{\text{Annex 1}}$). The agenda was adopted.

1.4 Declarations of conflicts of interest with regard to agenda items

The meeting chair requested all participants to declare any potential conflicts of interest for any of the agenda items, according to Article 9(2) of the Rules of Procedure. No conflicts of interest were declared at the meeting.

1.4 State of play with action points from Forum-34

The Harmonised Enforcement team (HET) (previously denominated as ECHA Forum Secretariat) informed the plenary on the status of action points from Forum-34 and highlighted the open actions.

1.5 Results of written procedures between Forum-34 and Forum-35

The meeting chair referred to the document with the results of the written procedures between Forum-34 and Forum-35.

Item 2 – Election of the Chair and Vice-Chairs of the Forum

2.1 Presentation of the candidates

The Forum elected, from among the members, the new Chair and Vice-Chairs of the Forum.

2.2 Candidate's motivation speech

Before the election, all the candidates explained their motivations to the plenary.

2.3 Election procedure

The election took place remotely, in which the Forum Members, with the right to vote, were able to cast their vote by secret ballot via a dedicated online tool.

2.4 Counting of the votes and announcement of the elected Forum Chair and Vice-Chairs

Katja vom Hofe (DE) was elected as the Chair, and Sinead McMickan (IE) and Henrik Hedlund (SE) were elected as the Vice-Chairs. Their mandates will run from 22 June 2020 until 21 June 2023.

The elected Chair of the Forum took over the chairing of the meeting.

Item 3 – Forum's transparency

3.1 Feedback collected on the "transparency document" from March 2020

HET reminded that the first document regarding transparency was delivered in March 2020 and the Forum was invited to provide input on the several proposals to increase Forum transparency and further improve stakeholders' engagement. Additionally, the Forum also provided feedback on such issues during the Forum's satisfaction survey 2019.

3.2 Results of the Forum members' satisfaction survey 2019

The Forum took note of the results of the feedback from the satisfaction survey on the activities taken place during 2019.

3.3 Discussion

HET summarised the pros and cons of each proposal for discussion.

The Forum members shared their views on the various proposals and would provide written feedback. Afterwards, HET would revise the proposals and include an assessment of benefits and costs. The revised document would then be submitted for discussion and agreement at Forum-36.

Item 4 – Forum's enforcement activities- Projects under finalisation

4.1 Cooperation with Customs 2

4.1.1 WG progress report

The WG chair summarised the work of the WG, which main task had been the analysis of the data collected from the participating countries and preparation of the project report.

4.1.2 Project results

The WG chair presented the main results of the project and the draft recommendations.

The presenter replied to the questions posed by some Forum members and informed the Forum would be consulted on the draft report during July 2020.

4.1.3 Mandate amendment

The WG requested for an extension of the reporting phase by September 2020. The Forum adopted the updated mandate ($\underline{Annex 2a}$).

Item 5 - Forum's enforcement activities- Ongoing projects

5.1 Member States reporting

5.1.1 WG progress report

The WG chair presented the status of the work of the WG and the issues for discussion with the Forum.

One pending task was related to the pilot phase of the REACH/CLP annual reporting (agenda item 5.1.2).

A second ongoing task of the WG was to recommend a harmonised definition of "control", for the purpose of reporting on REACH enforcement activities to COM and in the upcoming pilot on annual reporting. Both Forum and BPRS were surveyed on

this question and the WG was discussing the outcome. To complete this task, the WG requested for an extension of the timeline of the mandate (agenda item 5.1.3). COM welcomed this initiative from the WG, and indicated that – if agreed by the Forum – it can be integrated in the next reporting exercise to COM.

5.1.2 Discussion on the timing of the pilot exercise on annual reporting

The WG proposed the timing for this pilot to take place between January 2021 - December 2022. It would be followed by the evaluation period until mid-2023. The Forum agreed on this timeline to run the pilot exercise on annual reporting.

The WG invited COM to share with the Forum the experiences from the Member States reporting exercise of 2020 in a future opportunity.

5.1.3 Mandate amendment

The WG mandate was extended so that the WG could recommend a definition of "controls". The Forum adopted the updated WG mandate (<u>Annex 2b</u>).

5.2 Prioritisation of REF projects

5.2.1 WG progress report

The WG chair presented the outcome of the prioritisation exercise, where topics for projects were collected until 24 April 2020 from Forum members, COM, ECHA and ASOs. It included also a list of topics for potential pilot projects for discussion with the Forum (agenda item <u>5.2.2</u>).

The WG also reviewed the Registry of provisions tackled in the Forum projects and considered to add the BPRS projects as well. The Forum agreed for the WG to pose that question to the BPRS and invite a BPR expert to the WG for that specific task.

5.2.2 Discussion of the potential scope of REF-10 and pilot projects

The WG combined similar proposals and suggested a topic on the enforcement of REACH Annex XVII restrictions, substances in articles (SiA) duties and POPs restrictions. It would be an integrated check, based on a material approach, where different substances and duties could be checked.

Potentially all actors in the supply chain would be of interest for the project, and it would be possible to include cooperation with market surveillance authorities, customs and other relevant authorities.

The WG chair clarified that there was only one proposal for the Forum to select since it was a combination of various proposals. Some proposals were rejected for not fulfilling all the mandatory criteria or were repetitions from previous projects. Others that fulfil only some mandatory criteria were put forward as pilot project proposals.

Some Forum members expressed their support on the proposed topic "integrated control of products" and therefore the Forum agreed with this topic for the REF-10 project; the WG REF-10 (to be established at Forum-36) would further elaborate the scope of the project.

The Forum members were invited to submit comments in writing and express preference for one of the four proposed topics for pilot projects as well as a potential timeline.

5.2.3 Timeline of the future pilot project on bridging principles

The Forum looked at the timelines of the current and future projects and agreed to set-up the WG and initiate the preparatory phase of the pilot project on bridging principles in January 2021. However, the WG would be set up at the next Forum meeting (Forum-36).

5.2.4 Mandate amendment

The Forum adopted the updated mandate (<u>Annex 2c</u>).

5.3 REACH-EN-FORCE-7 on Registration

5.3.1 WG progress report

The WG chair summarised the activities of the WG, which were focused on the preparation of the project report.

5.3.2 Preliminary results

The WG chair presented the preliminary results of the project assessed by the WG so far. The WG would continue to work on the analysis of the data and prepare the recommendations from this project. The final report would be finalised in Q4 2020.

5.3.3 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2d).

5.4 Interlinks

5.4.1 WG progress report

The WG chair summarised the work of the WG during the last months, which focused on the revision of the interlinks guide. A new interlink will be added addressing potential revocations of registrations belonging to non-existent companies (see agenda point 14.4). The draft guide would be consulted with the Forum during the summer.

The WG noted the ECHA Secretariat report on measures that NEAs can apply for breaches of dossier evaluation duties, based on responses from Forum members on the measures questionnaire that was sent out to them to implement Action 12 of the REACH Evaluation Joint Action Plan (REAP). The report delivered a positive conclusion that available measures were effective in enforcing DEV decisions except for few known cases, which needed to be addressed.

The Forum members were invited to comment, in their individual capacities, on the ECHA Secretariat's report on measures applicable for breaches of DEV decisions.

5.4.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2e).

5.5 Implementation of Interact portal

5.5.1 WG progress report

The WG have tested the proper functioning of the tool after its updates and liaised with the WG Interlinks to discuss the plans for renewing the interlinks function in Interact Portal.

5.5.2 Update on ECHA IT tools for inspectors

HET informed that the consultation module in Interact portal was released in March 2020 and that a training was provided to Forum, BPRS and their WGs on 17 June 2020 via Webex. The presenter gave a demonstration of the consultation module.

The Forum was informed on other updates coming in the new release in October, which included the possibility for invited experts and observers to have access to specific agenda points of Forum/BPRS meeting without the need of a token. Moreover, the Forum members were invited to liaise with their BPRS member to discuss the possibility to use the current User Administrators for the Interact BPR as well.

The presenter also provided some updates concerning ICSMS and the PIC DRPI. COM representative thanked the Forum for providing feedback on the tool. Other users have been contacted and the collection of all replies and its assessment would be prepared and shared with the Forum.

5.5.3 Mandate amendment

The Forum adopted the updated mandate (<u>Annex 2f</u>).

5.6 REACH-EN-FORCE-9 on Authorisation

5.6.1 WG progress report

The WG continued preparing the draft REF-9 project manual, which will be consulted with the Forum during the summer. The date of the Training for REF-9 National Coordinators will be changed to align with the Training for Trainers event and it would be communicated to the Forum once scheduled.

The Forum members were invited to nominate National Coordinators for the REF-9 project, who would be also one of the trainees participating in the Forum Training for Trainers 2020 event.

5.6.2 Mandate amendment

The Forum adopted the updated mandate (<u>Annex 2g</u>).

5.7 Pilot project on recovered substances

5.7.1 WG progress report

The WG chair presented the status of the work developed by the WG. He addressed the proposal from IMPEL on the potential collaboration of this network with the WG (agenda item 9.1), and proposed a change in the timeline of the project and review of the mandate's objectives (agenda item 5.7.2).

He informed that the draft manual would be consulted with the Forum and the appointed National Coordinators during the summer.

As presented by the IMPEL representative, the Forum was invited to participate in the update of their Guidance "Making the Circular Economy work" to comment on the relevant REACH aspects of their guidance. The Forum members agreed to provide feedback to the IMPEL Guidance on the issues concerning REACH, in their individual capacities.

Considering the new proposed timeline of the project, the Forum Members were invited to re-assess their participation in the pilot project and nominate National Coordinators.

5.7.2 Mandate amendment

Because of the COVID-19 pandemic, Member States were still dealing with shortage of resources and uncertainties, having reservations in allocating resources to prepare for such projecting still in 2020. Therefore, WG suggested to postpone the start of the operational phase of this project to January 2021, with the duration of 12 months, to increase the possibility of having more participating countries.

The second objective of the mandate concerning the check of POPs was revised. It was clarified, but kept generic since it was an optional aspect of this project.

The Forum agreed with the proposed changes and adopted the revised mandate of the WG ($\frac{\text{Annex } 2h}{\text{D}}$).

5.8 REACH-EN-FORCE-8 on online sales

5.8.1 WG progress report

The Forum took note of the WG's progress report. Surveys to the National Coordinators were done to assess the status of the inspections and to identify any challenges faced by inspectors. In the survey in May, the National Coordinators were asked whether COVID-19 impacted the planned activities of REF-8 inspections. As expected, many reported challenges concerning allocation of resources as some of their tasks were diverted to other more urgent areas. Therefore, the WG proposed to monitor the situation with the last survey (in September 2020) and if the situation remains, the Forum would discuss in the plenary in October the need to extend the timeline of the operational phase. As some countries were badly affected by the pandemic, the Forum would be flexible and find a solution that would benefit all.

The WG held a Webex with the National Coordinators on 23 June 2020 to address all issues raised so far. The WG chair debriefed the Forum on the outcome of the meeting.

5.8.2 Mandate amendment

The Forum adopted the updated mandate (<u>Annex 2i</u>).

5.9 Enforceability of restrictions

5.9.1 WG progress report

The Forum Chair summarised the WG's activities related to the Forum advices, the revision of the compendium of analytical methods and the assessment of the new REACH Annex XVII restrictions.

On the compendium, the NEAs, laboratories and ASOs were invited to provide information on REACH Annex XVII restrictions, POPs and amendments to the current version of the compendium. In addition, the HET coordinated the input from the customs laboratories with DG TAXUD. After the collection of feedback, the WG would review the compendium.

The WG chair added that she participated in a meeting with the Custom's laboratories network (CLEN), where she presented the compendium. They welcomed the initiative of the Forum and could potentially send some feedback.

Replying to a question from COM, the WG chair noted that the working group on analytical methods was open to support other project preparations (*e.g.* REF-9 and Annex XIV substances). However, it was outside of the scope of the group and would require an update of its mandate. She suggested for the Forum to revise the mandate of the group in the future to accommodate any future work for all relevant

substances that might come under the ECHA's/Forum's remit. Nonetheless, it could be a good timing to invite the laboratories to submit information on analytical methods for Annex XIV substances covered by the REF-9 project, since the compendium was being revised and the laboratories were being contacted.

A Forum member shared that for the ADCO chairs IMP-MSG meeting, it was made a mapping of laboratory testing in the Member States, looking at the EU testing facilities. It was asked to identify product sectors and technical specifications the testing facilities could provide. The Forum could follow-up on this topic and learn from that.

5.9.2 Mandate amendment

The Forum adopted the updated mandate (<u>Annex 2j</u>).

5.10 Training for enforcement trainers 2020

5.10.1 WG progress report

The Forum took note of the activities of the WG. Due to the pandemic, the training in 2020 would take place remotely, on 25-26 November 2020. The WG would adapt the adopted training Agenda, without changing its content. Discussion on the practicalities of such remote training was taking place also with the BPRS Training WG to ensure the highest quality event possible to all trainees.

5.10.2 Mandate amendment

The Forum adopted the updated mandate (<u>Annex 2k</u>).

Item 6 – Conclusions from day 1

The conclusions and actions points collected during day 1 were discussed with the Chairs after the meeting and adopted at the end of day 2.

Item 7 – Enforcement and breaches related to COVID-19 epidemic

HET informed the Forum of the arrangements put in place by ECHA in several of its processes to facilitate the fulfilment of obligations by the industry during the COVID-19 pandemic, that affected the industry by interrupting supply chains, services and availability of resources. The duties which were directly subject to enforcement were related to REACH authorisation decisions (implementation of monitoring timelines may be affected) and inquiry and registration duties (companies may need to increase the volumes without having the required registration (or tonnage band) and find it challenging to address in time the incompleteness in dossiers).

Item 8 – Conclusions from day 2

The Forum adopted the conclusions and action points collected for the issues discussed during the previous day.

Item 9 – Cooperation with other networks

9.1 Future cooperation with IMPEL

A representative from the IMPEL network presented the organisation and their current project on waste management and circular economy. Moreover, their experts were revising their guidance on the Circular Economy and were exploring to have more practical examples on the interface between REACH and the Waste Framework Directive (WFD).

Considering the Forum's pilot project on Recovered Substances, he proposed some possibilities for cooperation between the Forum and IMPEL, mainly by joint inspections during the operational phase of the Forum's project and joint training (REACH and waste inspectors of the countries participating in the project), which would promote the exchange of knowledge, experiences, methodologies between the two inspectors.

The Forum members were also invited to comment on the IMPEL Guidance "Making the Circular Economy work" to have a harmonised view on how to address issues such as exemptions from REACH registration and other borderline cases. After a question from a Forum member, the presenter clarified that the input for the current guidance was gathered from many experts, however, not from any REACH authority. At that time, the focus was to understand the challenges the companies faced when dealing with REACH regulation. Therefore, a review of the guidance was planned and IMPEL welcomed the input from the REACH experts from the Forum. The review was scheduled to be completed by March 2021, with the possibility to be extended until the end of that year.

Replying to a Forum member, the presenter clarified that the practical tool on the "end of waste practical assessment" was part of the Guidance and was public. It could be accessed/used by both regulators and companies.

COM noted that non-EEA countries were members of IMPEL. The presenter added that the network aimed at knowledge-sharing and welcomed countries that were still developing their legislation as observers. The suggested cooperation with the Forum's WG would involve only authorities from the EU/EEA countries participating in the project.

A Forum member welcomed the cooperation between IMPEL and the Forum's pilot project, which was discussed in agenda item 5.7.

9.2 Updates from SLIC-CHEMEX

The Forum took note of the information provided in a meeting document with the updates of the SLIC-CHEMEX's work since November 2019.

9.3 Updates from ADCO Chairs meeting

The last meeting of the ADCO Chairs took place on 19 June 2020 (remotely) and the proceedings of the meeting would be shared with the Forum in writing after Forum-35 by the AT Forum member.

Item 10 – Updates from the ECHA Forum Secretariat 10.1 ECHA's Internal Audit - Main recommendations for the Forum

The Forum was audited by ECHA's Internal Audit Capability (IAC) during autumn 2019. The auditor interviewed Forum members, Management Board members, COM and ECHA staff and ASOs. There were no non-compliances nor critical recommendations. The auditor made some observations that could help improve the efficiency and effectiveness of the Forum's activities.

HET presented a potential action plan which involved the Forum members and invited the Forum to discuss the actions and submit feedback in writing after the meeting.

It was noted that the practical enforcement guides (documents prepared after each project for inspectors), available in Interact Portal, do not seem to be frequently downloaded by users. The Forum members were invited to promote these documents among the NEAs at the national level.

The Forum Chair requested for the full audit report to be shared with all Forum members since the Forum is a body of ECHA.

10.2 Inventory of recommendations of the Forum's projects

HET presented the idea of a compilation/inventory of the recommendations from the last projects finalised by the Forum. It was one of the recommendations of the Forum's internal audit to make the Forum projects more impactful.

The purpose was to ensure that the recommendations addressed by the Forum in the projects were shared with the relevant recipients of the recommendations described in the project reports (ECHA, NEAs, ASOs, COM, etc.). It would also serve Forum and ECHA Secretariat to facilitate follow-up of recommendations adopted in the project reports. HET would monitor regularly the possible implementation of the recommendations and would keep the Forum updated on the progress.

The Forum members were invited to comment on the inventory proposed.

COM representative welcomed the initiative and suggested the separation of the recommendations per actor instead of per project.

10.3 Dates of Forum meetings 2020/2021

HET reminded the dates of the future plenary meetings. ECHA management decided that no physical meetings would take place by 30 March 2021 due to the Covid-19 pandemic, hence the next two plenary meetings will still take place remotely:

- Forum-36 week 26-30 October 2020 (remote)
- Forum-37 week 15-19 March 2021 (remote)
- Forum-38 week 14-18 June 2021
- Forum-39 week 8-12 November 2021

Item 11 – Update on relevant developments by the Commission

11.1 General updates by the European Commission

COM representative (DG ENV) presented updates regarding the European green deal and the COM's chemical strategy for sustainability. It is foreseen that it would be adopted in September 2020 followed by its implementation between 2021-2024.

The COM was still working on the Member States reports and there were no further updates.

A COM representative from DG GROW added that the interim report on the REACH-Customs study was being finalized.

He informed that CEN, the European Committee for Standardization, was working on regulated chemicals in products and its first outcome was on polycyclic aromatic hydrocarbons (PAH) in rubber and plastic. He recommended for the Forum members to keep contact with the CEN national contact point to highlight which restriction would be a priority for the Member States.

Due to the COVID-19, the workshop on authorisation (scheduled for the end of March 2020) was postponed for after the summer. For the same reason, the

exchange of inspectors' activities could also change its format and options were being explored.

Replying to a Forum member, the next exchange of inspectors' programme was being developed and application for this programme would run until March 2021. Most likely the deadline for application would not be extended.

Replying to a Forum member, the COM representative confirmed that the changes in Annex II of REACH will apply only in 2021.

11.2 Follow-up of Action 12 of REACH Review

Action 12 was related to the improvement of the interactions between REACH and OSH regulations. The NEAs were surveyed and a report with a compilation of the information was prepared and delivered to COM to assist in the completion of this action.

COM had also been working on the improvement of SDS by, for example, defining the minimum requirements, digitalisation of SDS and mandating ECHA to develop methodologies for SDS for mixtures.

COM was also working at aligning the methodologies between OSH-REACH. Cooperation between the expert groups of each regulation have been tried, for example, RAC has been developing OELs for OSH.

11.2.1 Update on the Forum's report 'Survey OSH-REACH enforcement interactions'

The Forum Vice-chair informed that the Forum's report 'Survey OSH-REACH enforcement interactions' sent for COM would be publicly available in the Forum's website.

Item 12 – Conclusions from day 3

The Forum adopted the conclusions and actions points collected for the issues discussed during the previous day.

Item 13 – Practical issues for enforcement of REACH, CLP, PIC and POPs

HET summarised the status of the pending practical issues. It reminded of the new issue posted in HelpEx for Forum members to comment.

Issue 21.1 - Who is responsible for the elaboration of a Safety Data Sheet when an only representative is appointed?

HET summarised the issue and the comments received from the Forum members. The conclusion of the practical issue was revised, and a new proposal was presented at the meeting.

The Forum discussed the proposed draft conclusions. The draft conclusion would be revised followed by a commenting round with the Forum.

Issue 35.1 – Does REACH, CLP or PIC prevent the export of used and discarded corrugated roofing sheets filled with asbestos fibres that were in use since before 1 January 2005?

HET presented the issue and the proposed draft conclusion.

The Forum discussed the proposed draft conclusions. The draft conclusion would be revised to add different scenarios, followed by a via written procedure.

Issue 35.2 - Labelling requirements for chemical anchors (glass capsules)

The submitter presented the issue, which was concerning chemical anchors (glass capsules) and the deviation from the labelling requirements for the packaging immediately containing the substance or mixture.

HET introduced the draft conclusion and some Forum members commented on the proposed text. The text was edited at the meeting and the conclusion of this practical issue was adopted.

Issue 35.3 - Can the data from the SDS of a plant protection product authorised in one Member State be used to produce a SDS for a rebranded version of that plant protection product in another Member State without a letter of access?

The submitter presented the issue that concerned the Plant Protection Products (PPP) Regulation, which was outside the Forum's remit. Therefore, the proposed conclusion did not include reflections on the applicability of the provisions of this regulation but only related to REACH and SDS provisions.

The HET introduced the draft conclusion and some Forum members commented on the proposed text. Further feedback from the submitter would be sent after the meeting, followed by a written consultation.

Issue 35.4 - Harmonised enforcement of exemptions of CLP Article 29 duties

The submitter presented the issue that was observed during the operational phase of the Forum's project REF-6.

HET presented the proposed draft conclusion that considered the recent interpretation of the COM's legal services, which was also presented and discussed at the last HelpNet-CLP meeting.

HET would collect additional input from the members after the meeting, followed by a written consultation.

Item 14 - Updates from the ECHA Secretariat

14.1 Database on articles containing Candidate List substances under the Waste Framework Directive

The expert from ECHA Secretariat presented the REACH communication on substances in articles (SiA) and the notification of SCIP (**S**ubstances of **C**oncern **I**n articles as such or in complex objects (**P**roducts)), which was established under the Waste Framework Directive (WFD). Moreover, the presenter informed on the status of the SCIP data base and reflected on the recommendations to ECHA on the Forum enforcement project on SiA.

Replying to the Forum's comments, ECHA was not considering updating the Guidance for Substances in Articles in the short term and all relevant information/recommendations would be provided under the SCIP data base communications activities (ECHA website, to the Member States, etc.).

14.2 Update on "REACH review action 3"

The ECHA expert summarised the document provided for the meeting, which included the information on the work done during 2020 to identify mechanisms that could address the poor quality of the information provided through the SDS, in context of the REACH REVIEW Action 3. The future work would involve Member States' authorities, with the aim to help clarify the needs of duty holders to ensure that such mechanisms were workable and enforceable.

The Forum mandated three experts (AT Forum member, NO Forum alternate and SE expert) to collaborate with the actors involved in the REACH Review action 3. An additional question on the preferred way to collect feedback from the NEAs (*e.g.* dedicated Webex) was posed to the Forum, via written consultation.

14.3 Feedback received on the enforcement of Art 11

HET informed about the feedback received from the Forum members after the Forum-34 meeting on ECHA's proposal for a process of involving NEAs in the Lead Role Verification process and enforcement of REACH Article 11.

14.4 Follow-up on the process for revocations for non-existing ORs and non-compliant dossiers

The Chair indicated that the discussion on revocations for non-existing companies (formally known as "ghost ORs") was taking place within the work of the WG Interlinks.

14.5 Follow-up of ECHA Decisions: updates from ECHA
