The TCC plug-in

• Checks most of the Business Rules



- Simulates the Technical Completeness Check
- Verifies if minimum requirements are fulfilled
 - Checks relevant sections and endpoints based on tonnage band
- Two different results
 - Warning
 - Failure
- Can be run on the substance dataset or on dossier







ECHA strongly recommends that you do the following, as soon as possible:

- 1) Back-up your IUCLID data
- 2) Install Java 7
- 3) Upgrade IUCLID to 5.4.1

ECHA recommends this because versions of IUCLID prior to 5.4.1 work only with Java 6, and soon updates to Java 6 will no longer be made. This is a security issue.





How do I upgrade to IUCLID 5.4.1?

In all cases, the installer for Microsoft Windows can be used. For IUCLID 5.4.0 or 5.3.x, use the upgrade option of the installer.

Upgrade from IUCLID 5.4.0 to 5.4.1

or

Upgrade from IUCLID 5.3.x to 5.4.1

For IUCLID 5.2.x or earlier, use the installer to make a new installation of 5.4.1, and then use the restore function to transfer the data from your backup into the installation of 5.4.1.

When performing the fresh installation, on page 3 of the installer, change the database name from the default value to **iuclid541**, as shown below.

Database name:*	iuclid541
Database user nar	ne:* iuclid5

Be careful to launch IUCLID 5.4.1 using the newly created icon.





Key Messages

- Run the TCC plug-in both on the substance dataset AND on the dossier
- Make sure you have the latest software (IUCLID, plug-ins, Java)
- Confirm membership of joint submission
- Members can only submit their dossiers after Lead has passed business rules
