## **Final**

Minutes of the 55th meeting of the Committee for Socio-economic Analysis

31 May - 3 June and 7-8 June 2022

#### I. Summary Record of the Proceeding

#### 1) Welcome

María Ottati, Chair of the Committee for Socio-economic Analysis (SEAC), ECHA, welcomed the participants to the 55<sup>th</sup> meeting of SEAC.

The Chair informed the participants that the meeting would not be recorded. The list of attendees is given in Part III of the minutes.

#### 2) Adoption of the Agenda

The Chair introduced the final draft agenda of SEAC-55. The agenda was adopted without modifications (in line with SEAC/A/55/2022). The Chair mentioned that the meeting would be partly chaired by the Deputy Chair Kalle Kivelä.

The final agenda is attached to these minutes as Annex III. The list of all meeting documents is attached to these minutes as Annex I.

#### 3) Declarations of conflicts of interest to the Agenda

The Chair requested members and their advisors participating in the meeting to declare any conflicts of interest with any of the specific agenda items. One member and two advisors declared potential conflicts of interest regarding the substance-related discussions under Agenda Item 5.2b-5. Two members and two advisors declared potential conflicts of interest regarding the substance-related discussions under Agenda Item 5.2a-3. One member declared a potential conflict of interest regarding the substance-related discussions under Agenda Item 5.2a-1. Two members declared potential conflicts of interest regarding the substance-related discussions under Agenda Item 5.2a-2. These members did not participate in voting under those Agenda Items, as stated in Article 9(2) of the SEAC Rules of Procedure.

The Chair declared her absence of conflict of interest for all items of SEAC-55 plenary meeting. She noted that the Deputy Chair was involved in the preparation of the Annex XV dossier for the PFAs in Firefighting Foams restriction proposal, and would therefore not participate in discussions, but that he had no conflict of interest for the other items on the agenda.

The list with declared conflicts of interest is given in Annex II of these minutes.

#### 4) General SEAC procedures

#### a) Report on SEAC-54 action points and written procedures

The Chair informed the participants that all action points of SEAC-54 had been completed or would be followed up during the on-going SEAC-55 meeting.

The Chair also informed the Committee that the final minutes of SEAC-54 had been adopted by written procedure and had been uploaded to S-CIRCABC as well as on the ECHA website.

Representatives of the Commission updated the Committee on SEAC-related developments in the REACH Committee and in CARACAL. The Commission also provided an update from the REACH review.

#### b) Update of SEAC accredited stakeholders list (closed session)

The Committee reviewed the SEAC accredited stakeholders list. The Committee took note of and discussed the restricted meeting document (SEAC/55/2022/01). Following the discussions, SEAC agreed on the update of the list. The Chair informed SEAC that the Secretariat will publish the updated list on the ECHA website.

#### 5) Restrictions

#### 5.1 General restriction issues

#### a) Report from Working Group on qualitative assessments

The representative from the Working Group on qualitative assessments provided an update and SEAC discussed the progress made and issues the members would like to see reflected in the resulting paper. The members supported the approach taken by the working group and proposed some further ideas to be developed further. The regular stakeholder observers (EAERE, EEB, EUROMETAUX, CEFIC) commented on the methodology, the ranking of different parameters, and called for more transparency in qualitative assessment. The working group will report back in the upcoming meetings.

#### 5.2 Restriction Annex XV dossiers

#### a) Conformity check and key issues discussion

#### 1) Creosote and Creosote related substances

The Chair welcomed the Dossier Submitter's representative from France. She informed the participants that the restriction dossier was submitted by France on 1 February 2022, but it has been processed within the April submission window. The conformity check process was launched on 12 May and the SEAC commenting round finished on 25 May (there were two comments received from SEAC members). The Chair informed the participants that RAC would conclude on the conformity of the Annex XV dossier at RAC-61.

The Dossier Submitter representative provided a brief introductory presentation on the dossier. One of the rapporteurs presented the outcome of the conformity check and informed the Committee that they do not consider the dossier to be in conformity due to the lack of information on the scope of the proposed restriction and lack of information on the proportionality to the risk.

The Committee agreed that the dossier does not conform to the Annex XV requirements. In addition, the rapporteurs presented their recommendations to the Dossier Submitter, and these were supported by the SEAC members. As the Committee has considered the dossier not to be in conformity, the Secretariat will inform the Dossier Submitter about the reasons for non-conformity.

#### 2) Terphenyl, hydrogenated

The Chair welcomed the Dossier Submitter's representative from Italy. She informed the participants that the restriction dossier was submitted on 8 April 2022, and it has been processed within the April submission window. The conformity check process was launched on 12 May and the SEAC commenting round finished on 23 May (no comments received from SEAC members). The Chair informed the participants that RAC would conclude on the conformity of the Annex XV dossier at RAC-61.

The Dossier Submitter's representatives provided an introductory presentation on the restriction proposal. The SEAC rapporteurs then presented the outcome of the conformity check and the recommendations to the Dossier Submitter. The Committee agreed that the dossier conforms to the Annex XV requirements. The Chair informed the Committee that the six-month consultation of interested parties on the restriction proposal will be launched on 20 June 2022.

#### 3) N,N-dimethylacetamide

This agenda item was chaired by the Deputy Chair. The Chair welcomed the Dossier Submitter's representative from the Netherlands. He informed the participants that the restriction dossier was submitted on 8 April 2022, and it has been processed within the April submission window. The conformity check process was launched on 12 May and the SEAC commenting round finished on 23 May (no comments received from SEAC members). The Chair informed the participants that RAC would conclude on the conformity of the Annex XV dossier at RAC-61.

The Dossier Submitter's representatives provided an introductory presentation on the restriction proposal. The SEAC rapporteurs then presented the outcome of the conformity check and the recommendations to the Dossier Submitter. Members discussed the conformity check outcome and recommendations. The Committee agreed that the dossier conforms to the Annex XV requirements. In addition, the rapporteurs presented the key issues that they have identified for the evaluation of the restriction proposal. Members and regular and occasional stakeholder observers and their accompanying expert commented on the proposal. The Chair informed the Committee that the six-month consultation of interested parties on the restriction proposal will be launched on 20 June 2022.

#### b) Opinion development

# 1) Per- and polyfluoroalkyl substances (PFASs) in firefighting foams – First draft opinion

The Chair welcomed the Dossier Submitter's representatives from ECHA and the RAC rapporteurs. She informed the participants that the restriction dossier was submitted in January 2022 by ECHA.

The RAC rapporteurs informed the Committee that RAC had discussed its first draft opinion at the RAC working group on restrictions, as well as at RAC-61, and summarised the conclusions reached.

The SEAC rapporteurs then presented the first draft opinion. Members, a regular stakeholder observer (Client Earth) and an accompanying expert to a regular stakeholder observer (EEB) commented on the assessment of the justification whether the suggested restriction is the most appropriate EU-wide measure. Members, a regular stakeholder observer (EAERE), an accompanying expert to a regular stakeholder observer (EEB), an occasional stakeholder observer and their accompanying expert (EurEau), an expert invited by the secretariat (LASTFIRE), as well as the Commission, also commented on the cost assessment. Members, accompanying experts to regular stakeholder observers (EEB, ChemSec, Cefic) and experts invited by the secretariat (Werkfeuerwehrverband Deutschland e.V., LASTIFRE) discussed in particular the availability and technical feasibility of alternatives.

The Chair concluded that there was general support by SEAC on the justification for action on Union-wide basis and that a restriction under REACH is the most appropriate EU-wide measure. Regarding the costs assessment, SEAC supported the Dossier Submitter's approach and provisionally agreed that the cost assessment provides an indication of the possible order of magnitude of the costs of the restriction options.

The (co-)rapporteurs were requested to prepare the second draft opinion by August 2022, taking into account the SEAC-55 discussions, the comments received from the SEAC written commenting round and the comments from the Annex XV report consultation.

## 2) Substances containing polycyclic aromatic hydrocarbons (PAHs) in clay targets for shooting – Second draft opinion

No discussions were held at SEAC-55 due to skipping the second cycle for this case. The rapporteurs will prepare the second draft opinion for discussion at SEAC-56 in September 2022.

#### 3) Lead in outdoor shooting and fishing- revised fifth draft opinion

The Chair welcomed the Dossier Submitter's representative from ECHA, the regular and occasional stakeholders and their accompanying industry experts, invited experts, as well as the members of the SEAC support group which was established to support the rapporteurs in the development of the opinion. She summarised the state of play of the opinion-making process, noting that the sections of the opinion covering fishing had already been agreed in SEAC-54, with full support and agreement by SEAC on the Rapporteurs' conclusions.

The RAC rapporteur provided a report from the RAC discussions on this restriction proposal held during RAC-61, where RAC adopted its opinion. The SEAC rapporteurs then presented the revised fifth draft opinion to the Committee. Members supported the rapporteurs' conclusions on the need for an EU wide measure, proportionality, practicality, enforceability and monitorability. The regular stakeholder observers, together with their experts (ClientEarth, EEB, Eurometaux), commented on the availability of alternatives and the benefits assessment for the proposed restriction in relation to hunting ammunition. The occasional stakeholder observers (FACE, FITASC/ISSF, AFEMS) commented on the impacts of the proposed restriction. The invited expert from UNEP/AEWA commented on the environmental impact of sport shooting. The Chair concluded that there was full support and agreement by SEAC on the Rapporteurs' conclusions on the proposed restriction with respect to uses in hunting and sport shooting.

The Committee agreed on its draft opinion by consensus. The rapporteurs were requested, together with the Secretariat, to do the final editing of the SEAC draft opinion and to ensure that the supporting documentation (BD and RCOM) is in line with the agreed SEAC draft opinion. The Secretariat intends to launch the consultation on the SEAC draft opinion on 29 June 2021. Furthermore, the Chair reminded all participants that the SEAC opinion development would be extended until December 2022 (i.e. SEAC is expected to adopt its opinion at SEAC-57).

#### 4) 2,4-dinitrotoluene - Third draft opinion

This agenda item was chaired by the Deputy Chair. He welcomed the Dossier Submitter's representatives from ECHA and the RAC rapporteur. He informed the participants that the restriction dossier was submitted in August 2021 under Art 69(2) of REACH and follows a simplified opinion development approach. The RAC rapporteur provided a report from the RAC discussions on this restriction proposal held during RAC-61, where RAC adopted its opinion. The SEAC rapporteurs then presented the third draft opinion to the Committee.

The Committee agreed on its draft opinion by consensus. The rapporteur was requested, together with the Secretariat, to do the final editing of the SEAC draft opinion and to ensure that the supporting documentation (BD and RCOM) is in line with the agreed SEAC draft opinion. The Secretariat intends to launch the consultation on the SEAC draft opinion on 15 June 2021. SEAC is expected to adopt its opinion at SEAC-56.

## 5) 1,6,7,8,9,14,15,16,17,17,18,18-dodecachloropentacyclo-[12.2.1.1<sup>6,9</sup>.0<sup>2,13</sup>.0<sup>5,10</sup>]octadeca-7,15-diene (Dechlorane Plus) – draft of the SEAC final opinion

The Chair welcomed the Dossier Submitter's representatives from Norway, the RAC rapporteur as well as the regular stakeholder observers. She informed the participants that the restriction dossier was submitted in April 2021.

The SEAC (co-)rapporteurs then presented the draft of the SEAC final opinion and the outcome of the consultation on the SEAC draft opinion. Members expressed their support for the SEAC opinion. The European Commission representative and the RAC rapporteur asked the rapporteurs clarifying questions regarding the sensitivity analysis and the derogations.

The Committee adopted its final opinion by consensus. The rapporteurs were requested, together with the Secretariat, to do the final editing of the SEAC final opinion and to ensure that the supporting documentation (Background Document and responses to comments from the consultation) is in line with the adopted SEAC final opinion.

#### 5.3 Appointment of (co-)rapporteurs for restriction dossiers (closed session)

SEAC agreed on the updated pools of (co-) rapporteurs for the upcoming restriction proposals (considered as agreement on appointment in line with the restricted room document SEAC/55/2022/02rev1). The members were invited to volunteer for the pools of (co-)rapporteurs.

#### 6) Authorisation

#### 6.1 General authorisation issues

#### a) Update on incoming/future applications

The Secretariat presented information on incoming/future applications for authorisation and review reports, expected workload in 2022, and timelines.

SEAC took note of the update on the new applications for authorisation received during the May 2022 submission window and other AfA-related updates.

#### b) Update of technical guidance for rapporteurs

The Secretariat presented and SEAC discussed the updated version of the technical guidance for rapporteurs.

The Secretariat will consider the discussion and update the document and will publish it on S-CIRCABC.

#### 6.2 Authorisation applications

#### a) Discussion on key issues

1) 10 applications for authorisation (chromium trioxide and trixylyl phosphate) from February 2022 submission window

The Secretariat, in cooperation with the SEAC rapporteurs, provided general information regarding the new applications for authorisation, and specified the identified key issues in the applications listed below:

#### b) Agreement on draft opinion

1. 242\_RR1\_TCE\_Microporous (1 use)

This is a review report on a single use of trichloroethylene:

Use 1: Trichloroethylene used as extraction solvent in the manufacture of polyethylene separators for lead-acid batteries.

SEAC members discussed substitution activities by the authorisation holder and technical and economic feasibility of alternatives. A representative of ClientEarth contributed to the discussion.

The Committee agreed on the draft opinion with editorials agreed at SEAC-55 by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinion. The Secretariat will send the draft opinion to the authorisation holder for commenting.

#### 2. 243\_RR1\_TCE\_DOMO (1 use)

This is a review report on a single use of trichloroethylene:

Use 1: Industrial use as an extraction solvent for the purification of caprolactam from caprolactam oil.

SEAC members discussed substitution activities by the authorisation holder, shortlisted alternatives, and the profit loss calculation in the socio-economic analysis by the authorisation holder, as well as a length of the review period. A representative of the European Commission contributed to the discussion.

The Committee agreed on the draft opinion by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinion. The Secretariat will send the draft opinion to the authorisation holder for commenting.

#### 3. 244\_CT\_Cromaplast (2 uses)

This is an application for authorisation on two uses of chromium trioxide:

Use 1: Industrial use of CrO<sub>3</sub> in the pre-treatment (etch) in the chrome plating process of automotive plastic components.

Use 2: Industrial use of CrO<sub>3</sub> in the chrome plating of automotive plastic components.

SEAC members discussed a length of the review period, availability of alternatives and substitution activities by the applicant, comments received during the third-party consultation on the two uses, calculation of profit losses in the socio-economic analysis by the applicant, and non-use scenarios.

The Committee agreed on the draft opinions with editorials agreed at SEAC-55 by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinions. The Secretariat will send the draft opinions to the applicant for commenting.

#### 4. 245\_CT\_Newform (1 use)

This is an application for authorisation on a single uses of chromium trioxide:

Use 1: Electroplating of different types of substrates using chromium trioxide to achieve functional surfaces with high durability and a bright or matt silvery appearance for sanitary applications.

SEAC members discussed a length of the review period, availability and suitability of alternatives and substitution activities by the applicant, as well as the evidence substantiating customer requirements.

The Committee agreed on the draft opinion with editorials agreed at SEAC-55 by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinion. The Secretariat will send the draft opinion to the applicant for commenting.

#### 5. 246 MOCA Courbis (1 use)

This is an application for authorisation on a single use of 2,2'-dichloro-4,4'-methylenedianiline (MOCA):

Use 1: Industrial use of 2,2'-dichloro-4,4'-methylenedianiline (MOCA) in the manufacture of hot cast polyurethane products.

SEAC members discussed availability of alternatives in general in the EU, and the methodology used by the applicants to calculate the monetised risks of continued use.

The Committee agreed on the draft opinion by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinion. The Secretariat will send the draft opinion to the applicants for commenting.

#### 6. 247\_OPE\_Boehringer\_2 (1 use)

This is an application for authorisation on a single use of 4-(1,1,3,3-tetramethylbutyl) phenol, ethoxylated (4-tert-OPnEO):

Use 1: Use of 4-(1,1,3,3-tetramethylbutyl)phenol, ethoxylated as a detergent in the purification of lipidated OspA protein subsequently used for manufacturing of Lyme disease vaccine candidate.

SEAC members briefly discussed incineration of the 4-tert-OPnEO containing waste and regulatory costs as they are presented in the Socio-economic Analysis by the applicant.

The Committee agreed on the draft opinion by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinion. The Secretariat will send the draft opinion to the applicants for commenting.

#### 7. 248\_NPE\_OCV (1 use)

This is an application for authorisation on a single use of 4-nonylphenol, branched and linear, ethoxylated (4-NPnEO):

Use 1: Mixing by the Applicant of a NPnEO-containing epoxy resin, resulting in mixtures containing < 0.1 % w/w of NPnEO for the manufacture of glass fiber articles for critical composite helicopter parts, that is exempt from authorisation under REACH Art. 56(6)(a).

SEAC members briefly discussed one of the potential alternative substances in the Analysis of Alternatives.

The Committee agreed on the draft opinion by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinion. The Secretariat will send the draft opinion to the applicants for commenting.

SEAC members discussed availability of alternatives and substitution activities by the four applicants, as well as a part of the non-use scenarios related to decontamination costs.

The Committee agreed on the four draft opinions with editorials agreed at SEAC-55 by consensus. The rapporteurs, together with the Secretariat, will do the final editing of the SEAC draft opinions. The Secretariat will send the draft opinions to the applicants for commenting.

# 6.3 Appointment of (co-)rapporteurs for authorisation applications (closed session)

The pool of (co-)rapporteurs, as outlined in the restricted room document SEAC/55/2022/03 was agreed by SEAC.
