Background to the dispute and remedy sought

The Appellant registered potassium iodide (EC No 231-659-4) as lead registrant for a ‘*joint submission*’.

Another registrant subsequently registered potassium iodide as lead registrant for a separate ‘*joint submission*’.

On 31 July 2018, the European Chemicals Agency (the ‘Agency’) issued a communication to the members of the substance information exchange forum (‘SIEF’) for potassium iodide. In the communication, the Agency requested the members of the SIEF to inform it of whether the Appellant or the other registrant had registered potassium iodide as lead registrant with their agreement.

By 16 September 2018, seven members of the SIEF informed the Agency that they consented to the submission of information on their behalf by the Appellant as lead registrant, whilst 18 members of the SIEF stated that they consented to the submission of information on their behalf by the other registrant as lead registrant.

On 9 October 2018, the Agency adopted the Contested Decision. In essence, the Contested Decision recognised the other registrant as the lead registrant for potassium iodide and instructed the Appellant and the members of the Appellant's *'joint submission'* to become members of the other registrant's *'joint submission'*.

On 14 December 2018, the Appellant filed this appeal. It requested the Board of Appeal to annul the Contested Decision and instruct the other registrant and the members of that registrant's *'joint submission'* to become members of the Appellant's *'joint submission'*.

Pleas in law and main arguments

The Appellant argued, in essence, that the Contested Decision was vitiated by several errors of assessment because the Agency failed to take into account all relevant information and because the Appellant is the only rightful lead registrant for potassium iodide.

The Appellant also claims that the procedure used by the Agency to address the breach of the obligation to submit data jointly lacked transparency.

Other information

The Executive Director rectified the Contested Decision by withdrawing it in its entirety. The Appellant subsequently withdrew the appeal. The case was closed by the Chairman of the Board of Appeal on 15 February 2019.
