

Transfers within the budget 2022 since last notification

68th Meeting of the Management Board 15-16 December 2022

Key message

The Management Board (MB) is invited to take note of the budget transfers carried out under the responsibility of the Acting Executive Director since last notification in September 2022.

In line with Article 26(1) of ECHA's Financial Regulation, the budget transfers carried out (by 22 November 2022) under the responsibility of the Acting Executive Director since the last notification to the Management Board are listed hereunder:

a) 26 October 2022: Transfer within BIOCIDES Title 4 -Operational expenditure

The items incorporated in the amended Procurement Plan 2022 required certain budgetary reallocations. There was a higher than anticipated need on budget line 4008 (Scientific IT tools) and, at the same time, there were funds available on budget line 'Substances, products and technical equivalence' within the same title. Therefore, a transfer between budget lines within Title 4 (as per the table below) was required.

b) 16 November 2022: Transfer within REACH/CLP Title 3 - Operational expenditure

In developing a CLP guidance document on Physical Hazards, ECHA identified a need to arrange a physical meeting with a small group of experts from the EU Member States and industry to support the drafting process. The estimated cost was EUR 8,000 and was not anticipated in the budget. As there was a surplus on budget line 3003 (Registration, data sharing and dissemination), a transfer between budget lines within Title 3 (as per the table below) was required.

A review of Title 5 budget revealed that the actual costs on budget line Communications, including Translations, were lower than anticipated.
