Data requirements

Substance identity

Identification

- IUPAC name
- Numerical identifiers if available (EINECS, ELINCS or CAS number)
- Structural formula
- Molecular formula and molecular weight

Data requirements

Substance identity

Composition

- Constituents, impurities, additives
- Substance purity
- Typical concentration and concentration range
- Description of manufacturing process for UVCB substances

Analytical data

- Spectral data
- Chromatographic and other relevant analytical data

Data requirements

Substance identity

- Substance naming, especially for multi-constituent and UVCB substances can be challenging
 - Check [Guidance on substance identification](#)
- Tip! export the EC number from:
 - Joint Submission page
 - Pre-SIEF page
 - Successful inquiry submission report in Reach-IT

Data requirements

What is your substance used for

- First, identify your markets: where and for what is your substance used
- As a member, check what your lead has submitted and adapt to your own supply chain
- If the substance is already registered, declared uses can be found on our website by searching for the registered substance

Data requirements

What is your substance used for – use maps

- Downstream user industry sectors provide use maps with agreed ways of describing uses for a range of common products
- Search the [use map library](#)
- Use maps are essential for your chemical safety assessment
- Information of typical conditions of use in many industry sectors available in the library (SWEDs, SCEDs and SPERCS)

Preparing a dossier

Pre-submission checklist

- Run the validation assistant and fix any issues
- Check that your substance name and identification number are in line with the joint submission
- Has your lead agreed to submit the Chemical Safety Report and/or Guidance of Safe Use on behalf of the member?
- Check from the joint submission page in REACH-IT

Submit your registration in REACH-IT

- You need to pass pre-validation and business rule checks before your submission is considered submitted
- Remember to fix issues and resubmit as soon as possible after failing business rules
- You have as many attempts as you need
- If you can't fix the issues and pass the business rules, contact us

You must give at least one constituent in IUCLID section 1.2. In addition, you must assign a reference substance for all the constituents.

✗ BR175

At least one composition in IUCLID section 1.2 must reflect the composition manufactured/imported by the submitting legal entity. To this end, indicate the 'Type of composition' as 'legal entity composition of the substance'.

✗ BR176


You must indicate the field 'Type of composition' for each composition record in IUCLID section 1.2. If you select 'other:', you must fill in the adjacent free text field.

- 1 ✓ Pre-validation
- 2 ✓ Business rules check
- 3 ⚙️ Technical completeness check
- 4 Financial completeness check
- 5 Overall completeness check
- 6 Submission outcome

Follow your registration in REACH-IT

- Once your submission has passed business rules
 - You will receive an invoice
 - Your submission will enter the technical completeness check
- Technical completeness check webinar on 15 March
- Comply with legal deadlines given in official communication ('key documents' in REACH-IT)
- Email notifications for new tasks and messages - Make sure your email notification settings are up to date

Take home messages

- Data requirements
 - Substance Identity
 - Description of Uses
- Check that your substance is in line with your joint submission
- Pass business rules check
- Follow your submission and comply with deadlines
