## **Biocides dissemination**

- Improved communication of information on risks resulting from biocidal products
- Enriched biocides dissemination pages will be available from end November 2018
  - Biocidal active substances
  - Biocidal products



# What will be available

- Extended search functionalities
  - e.g. by hazards and uses of the products, authorisation holder or authorisation type, search by Annex I substance
- Further detail on biocidal products
- Access to data from current and previous lifecycles of active substance approvals and product authorisations
  - initial applications, subsequent amendments and renewals
- Automatic publication of documents (faster publication)
- User interface improvements

# **SPC and other product documents**

- Final SPCs, non-confidential assessment reports and decision documents will be published automatically from the submission tool, R4BP 3
  - Only SPCs uploaded or submitted after 1 Jan 2016 are subject to dissemination
  - New: Final SPC will not display the function of "other substances" or of "substances of concern"
  - Assessment reports and decision documents published if marked in R4BP 3 as "public"
