On a notification for placing on the Latvian market of the biocidal product Silence Piège à mouches

Latvian Environment, Geology and Meteorology Centre (LEGMC) on 4th August 2022 received a notification for placing on the market of the biocidal product **Silence Piège à mouches** in accordance with Article 27 of the Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) 528/2012) submitted by **Arthur Schopf Hygiene GmbH & Co. KG** through Register for Biocidal Products.

The authorisation under the simplified procedure according Article 25 of the Regulation (EU) 528/2012 for biocidal product **Silence Piège à mouches** is granted in France on the following terms:

- **Product type 19** Repellents and attractants;
- Trade names: Silence piège à mouche; Silence Appât à Mouches; Silence Fliegenfalle; Silence Fliegenköder; Silence Fly Trap; Silence Fly Bait; Dr. Stähler Fliegenfalle; Dr. Stähler Fliegenköder; Goldin Fliegenfalle; Goldin Fliegenfalle N; ATAK Past na Mouchy; ATAK Návnada na Mouchy; Scatch Fliegenfalle; Scatch Fliegenköder; Scatch Fly Trap; Scatch Fly Bait; Ardap Fliegenfalle; Equisept Fliegenfalle; Gardigo Fliegenfalle; Trapmaster-FT; FT-100; MT-100; FX-Master; Super Trap Flies; Super Trap Mosche; Agraro Fliegenfalle Outdoor; Capito Fliegenfalle; Silva Fliegenfalle; Cifo Fly Trap; Windhager Fliegenköder; Silence Musès gaudyklė; Silence Musès masalas; Silence Lapač much; Silence Muškařská návnada; Silence vliegaas; Silence vliegenval; Silence Mušu slazds; Silence Mušu ēsma;
- **Users:** non-professional;
- **Product description:** attractant for the control of house fly;
- **Target organisms:** house fly;
- **Packaging:** trap bottle containing 1 Polyvinyl alcohol water-soluble sachet (20g);
- **Product stability:** up to 3 years.

Silence Piège à mouches contains **30% w/w Saccharomyces cerevisiae (yeast)** (CAS No.: 68876-77-7) and **20% w/w Powdered egg** (CAS No.: n/a; EC No.: n/a) as active substances.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **Silence Piège à mouches** developed by the reference Member State.

Therefore, in accordance with Article 27 of Regulation (EU) No 528/2012, LEGMC accepts the notification for placing on the Latvian market of the **Silence Piège à mouches**.



LEGMC assigns an authorisation number **FR-2022-0049**. The authorisation number is valid until 20th June 2032 and shall be indicated on the label.

The information on the label (and if applicable an enclosed instruction of use) should be as it is indicated in the authorisation of above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State. The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006, shall be applied.

Additionally LEGMC would like to inform that **Arthur Schopf Hygiene GmbH & Co. KG** is fully responsible of the content of the biocidal product, as well as its labelling, instruction of use and safety data sheet.

If the authorisation issued by reference Member State is amended or revoked, **Arthur Schopf Hygiene GmbH & Co. KG** shall inform LEGMC on the made changes.
