

Transfers within the budget since last notification

The budget transfers carried out (by 01 September 2018) under the responsibility of the Executive Director since the last notification to the Management Board are listed hereunder;

a) On 27 July 2018, transfer within Biocides Title 1 – Staff - to cover the higher than estimated need for interim support. As the budget for salaries is provisional by nature and the initial budget needs are established on the basis of the establishment plan, there is an inherent uncertainty in this planning. The cost estimates can be more accurately assessed only during the budget year when the entitlements and other variable costs of the recruited staff are known. The amount was transferred from budget line 1113 where, based on the current estimates, the needs are lower than initially estimated, as per the table below.

b) On 28 June 2018, 3 transfers in total (one within each regulation) for REACH/CLP, Biocides and PIC Title 2 – Building, Equipment and miscellaneous operating expenditure, to cover the higher than estimated insurance premia for non-statutory staff, Committee members and other visitors.
