4.1 Use description

Use 1 - Pheromone glue trap to control moths by mating disruption

Product type	PT19 - Repellents and attractants (Pest control)
Where relevant, an exact description of the authorised use	Per cupboard or for a small room, use 1 trap. Assemble larger rooms with 2 traps. Traps should be inspected at least once a week and replaced after 6 weeks or, if covered with moths.
Target organism(s) (including development stage)	Pyraloidea: Plodia interpunctella-Indian meal moth-Adults
Field(s) of use	Indoor The ready-to-use product is used in rooms or cupboards where well packaged food or feedstuff is stored.
Application method(s)	Stored product protection /Food protection - Traps containing the active substance are fixed in rooms or cupboards where well packaged food or feedstuff is stored.
Application rate(s) and frequencies	Application rate is 1 trap per cupboard or small room or 2 traps for a large room. The maximum application rate is determined by the amount of active substance on each trap (2 mg). - 100 - Timing: Preventive and upon infestation. Number: Traps should be inspected at least once a week and replaced after 6 weeks or, if covered with moths.

4.1.1 Use-specific instructions for use

The product "Food moth trap" consists of a cardboard carrying the pheromone, which is covered with sticky glue. The trap is fixed to a solid background with a tape on its back. A silicone paper is then removed from the sticky glue on front of the trap for its activation. Food or feed has to be stored in tightly closed containers (glass or plastic).

4.1.2 Use-specific risk mitigation measures

Keep out of reach of children.
Avoid contact with the product (adhesive tape).
Do not discharge into sewage/surface or groundwater.
Do not use in spaces where un-packaged food or feed is kept.

4.1.3 Where specific to the use, the particulars of likely direct or indirect effects, first aid instructions and emergency measures to protect the environment

Due to the application and dosage of the biocidal product (active ingredient on carrier (cardboard)) direct or indirect impact is not expected under foreseeable conditions of use.

After skin contact: Instantly wash with water and soap and rinse thoroughly. If skin irritation continues, consult a doctor.

After eye contact: Rinse opened eye for several minutes under running water. If symptoms persist, consult doctor.

The used product can be disposed in household rubbish.

Store in a cool and dry place. Shelf life: 4 years.
