On an authorisation of the biocidal product Wolsit F-15T

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Wolman Wood and Fire Protection GmbH** on 27 April 2018 concerning an authorisation of **Wolsit F-15T** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **Wolsit F-15T** developed by the reference Member States – Germany.

Therefore, in accordance with Article 34 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (Regulation (EU) No 528/2012), LEGMC authorises the **Wolsit F-15T** on the basis of mutual recognition process.

The authorisation holder for **Wolsit F-15T** in Latvia is:

Wolman Wood and Fire Protection GmbH

The biocidal product **Wolsit F-15T** contains following active substances:

- **tebuconazole** (CAS No 107534-96-3, EC No 403-640-2), concentration **7.81%**;
- **coco alkyltrimethylammonium chloride (ATMAC/TMAC)** (CAS No 61789-18-2, EC No 263-038-9), concentration **0.105%**;
- **propiconazole** (CAS No 60207-90-1, EC No 262-104-4), concentration **7.89%**.

LEGMC assigns the authorisation number for biocidal product Wolsit F-15T:

LV/2021/MR/012

The authorisation is valid until 23 June 2026.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of **Wolsit F-15T** through mutual recognition is granted on the following terms:

- Product type: 8 – Wood preservatives;
- Target organisms: Wood destroying fungi (brown rot and white rot);
- Users: industrial;
- Product description: ready to use product for glue-line treatment in closed systems;
- Product stability: shelf life 13 months;
- Use area: indoor areas;

- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the product **Wolsit F-15T** in the composition, form and packing for which the authorization for **Wolsit F-15T** is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the **Wolsit F-15T** should be as it is indicated in the authorisation of above-mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- *Article 69 Regulation (EU) No 528/2012;*
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;*
- all other relevant legislation shall be applied.

Wolman Wood and Fire Protection GmbH shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **Wolsit F-15T** through mutual recognition may be re-opened for review before 23 June 2026.

Application on renewal of an authorisation shall be submitted according to *Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.*

Additionally, LEGMC would like to inform that Wolman Wood and Fire Protection GmbH is fully responsible of the content of the biocidal product **Wolsit F-15T** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Wolman Wood and Fire Protection GmbH to notify the above-mentioned information down to supply chain.
