(Testing proposal - Rectification by Executive Director – Discontinuation of proceedings – Refund of appeal fee)

Contested decision

TPE-D-0000002006-86-03/F of 7 February 2012 adopted by the European Chemicals Agency (hereinafter the 'Agency') pursuant to Article 40(3) of Regulation (EC) No 1907/2006 of the European Parliament and of the Council concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (OJ L 396, 30.12.2006, p.1; corrected by OJ L 136, 29.5.2007, p. 3) (hereinafter the 'REACH Regulation')

Decision

- 1. On 30 April 2012, the Appellant filed an appeal at the Registry of the Board of Appeal against the contested decision which was taken in relation to a testing proposal. According to the contested decision, the Appellant was requested to carry out a long-term toxicity test on fish.
- 2. Pursuant to Article 93(1) of the REACH Regulation, on 30 May 2012, the Executive Director of the Agency rectified the contested decision (hereinafter the 'rectification') and the rectified decision was replaced by another decision.
- 3. Following the rectification, the Appellant was asked by letter dated 5 June 2012 to inform the Board of Appeal whether or not it intends to continue with the appeal.
- 4. By letter received at the Registry of the Board of Appeal on 18 June 2012, the Appellant informed the Board of Appeal that it had decided to withdraw the appeal.
- 5. As the Appellant has decided to withdraw the appeal, the case should therefore be closed.
- 6. Furthermore, pursuant to Article 10(4) of Commission Regulation (EC) No 340/2008 of 16 April 2008 on the fees and charges payable to the European Chemicals Agency pursuant to Regulation (EC) No 1907/2006 of the European Parliament and of the Council on the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) (OJ L 107, 17.4.2008, p. 6), where the Executive Director of the Agency rectifies a contested decision, the Agency shall refund the appeal fee. Consequently, the Agency should be ordered to refund the Appellant the appeal fee.

ORDER

On those grounds,

THE BOARD OF APPEAL

hereby:

- 1. Closes appeal case A-002-2012.
- 2. Orders the refund of the appeal fee.
