On an authorisation of the biocidal product family SANYTOL DETACHANT FRESH

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **GRUPO AC MARCA S.L.** on 20 December 2018 concerning an authorisation of **SANYTOL DETACHANT FRESH** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **SANYTOL DETACHANT FRESH** developed by the reference Member States – France.

Therefore, in accordance with Article 34 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (Regulation (EU) No 528/2012), LEGMC authorises the **SANYTOL DETACHANT FRESH** on the basis of mutual recognition process.

SANYTOL DETACHANT FRESH contains active substance **Peracetic acid generated from tetra-acetylenediamine (TAED) and sodium percarbonate** at the concentration range **6.93 – 8.53 %**.

LEGMC assigns the authorisation number LV/2021/MR/016.

The authorisation is valid until 12th August 2031.

In accordance with Article 22(2)(d) of the Regulation (EU) 528/2012 authorisation numbers with the following suffix for biocidal products within family are indicated in the following table:

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation is granted on the following terms:

- Product type: 2 – Disinfectants and algacides not intended for direct application to humans or animals;
- Target organism: bacteria, yeasts and viruses;
- Users: non-professional;

- Product description: water soluble granule - automatic and handwash laundry disinfection – household application;
- Product stability: up to 24 months;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to **SANYTOL DETACHANT FRESH** in the composition, form and packing for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the **SANYTOL DETACHANT FRESH** should be as it is indicated in the first authorisation of above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- *Article 69 Regulation (EU) No 528/2012;*
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;*
- all other relevant legislation shall be applied.

GRUPO AC MARCA S.L. shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **SANYTOL DETACHANT FRESH** through mutual recognition may be re-opened for review before 12 August 2031.

Application on renewal of an authorisation shall be submitted according to *Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.*

Additionally LEGMC would like to inform that GRUPO AC MARCA S.L. is fully responsible of the content of **SANYTOL DETACHANT FRESH** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask GRUPO AC MARCA S.L. to notify the above mentioned information down to supply chain.
