## On the renewal of authorisation for Rodenticids Brodifacoum Fresh Bait

Latvian Environment, Geology and Meteorology Centre (LEGMC) received an application submitted by Detia Freyberg GmbH on the 6<sup>th</sup> July 2015 for renewal of national authorisation in accordance with Article 31(1) of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* for **Rodenticids Brodifacoum Fresh Bait** (authorisation number: LV/2014/MR/003) through Biocidal Product Register (Asset No. LV-0006216-0000).

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **Rodenticids Brodifacoum Fresh Bait** developed by the reference Member State – Germany.

Therefore, in accordance with Article 5 of the Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for renewal of authorisation of biocidal products subject to mutual recognition the authorisation for Rodenticids Brodifacoum Fresh Bait is renewed and is valid until 25 February 2023.

Rodenticids Brodifacoum Fresh Bait contains 0.005% of brodifacoum (CAS No. 56073-10-0; EC No. 259-980-5) and is renewed on the following terms:

- Product type: it is only authorised for use as a product type 14 Rodenticide house mice (Mus musculus) and brown rats (Rattus norvegicus);
- Users: trained professional;
- Product description: for trained professional ready-to-use bait to be used in tamper-resistant bait stations, covered and protected baiting points;
- Product stability: shelf life 24 months;
- Use area: indoors, outdoors around buildings;

This letter is integral part of authorisation letter (No. 4-6/1077) issued by LEGMC on the 29<sup>th</sup> of May 2014.

LEGMC would like to ask **Detia Freyberg GmbH** to notify the above mentioned information down to supply chain.
