## On a notification for placing on the Latvian market of the biocidal product BG-Sweetscent

Latvian Environment, Geology and Meteorology Centre (LEGMC) on 23<sup>rd</sup> March 2023 received a notification for placing on the market of the biocidal product **BG-Sweetscent** in accordance with Article 27 of the Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) 528/2012) submitted by **Biogents AG** through Register for Biocidal Products.

The authorisation under the simplified procedure according Article 25 of the Regulation (EU) 528/2012 for biocidal product **BG-Sweetscent** is granted in Slovenia on the following terms:

- **Product type:** 19 Repellents and attractants;
- **Users:** professional and non-professional (general public);
- **Product description:** mosquito attractant;
- **Target organisms:** Asian tiger mosquito (*Aedes albopictus*) adults;
- **Packaging:** as indicated in Summary of Product Characteristics;
- **Product stability:** 2 years.

**BG-Sweetscent** contains **0,98% w/w Lactic acid** (CAS No.: 50-21-5; EC No.: 200-018-0) as active substance.

Trade names of **BG-Sweetscent** in Latvia are: BG-Mozzibait, BG-Sweetscent, Biogents Mückenlockstoff, BG-Homescent.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **BG-Sweetscent** developed by the reference Member State.

Therefore, in accordance with Article 27 of Regulation (EU) No 528/2012, LEGMC accepts the notification for placing on the Latvian market of the **BG-Sweetscent**.

LEGMC assigns an authorisation number EU-0026801-0000. The authorisation number is valid until 1<sup>st</sup> July 2032 and shall be indicated on the label.

The information on the label (and if applicable an enclosed instruction of use) should be as it is indicated in the authorisation of above mentioned product, taking into account also the



information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State. The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006, shall be applied.

Additionally LEGMC would like to inform that **Biogents AG** is fully responsible of the content of the biocidal product, as well as its labelling, instruction of use and safety data sheet.

If the authorisation issued by reference Member State is amended or revoked, **Biogents AG** shall inform LEGMC on the made changes.
