Issues for consideration

- If the Management Board (MB) appoints/renews these members, RAC will have 44 members versus a potential capacity of 60 members (not including 4 co-opted members;) and SEAC will have 31 members versus a potential capacity of 60 members (not including 4 co-opted members). Member States are strongly encouraged to nominate members to the ECHA committees in order to increase their working capacity.
- Each Member State may nominate maximum two candidates to membership of RAC and SEAC. The Executive Director establishes a list of nominees, which is published on the ECHA website. The MB then appoints the members of the Committee from this list.
- Committee Members should be appointed for their experience in performing the tasks specified in the REACH Regulation. The membership in the Committees is for a term of three years and is renewable.
- Member States were asked to make their nominations in accordance with the ECHA eligibility criteria. They also committed in writing to providing adequate scientific and technical resources to the nominated members and to enable them to use at least 50% of their working time for this task.
- In addition to the review of their CV and other nomination information by the Committee Chairs, the new nominees were interviewed to make sure that they understand the level of commitment in terms of time and contribution to the Committees and confirm that they are available.

Annex 1: Summary information about the persons proposed for appointment/renewal

MS	New RAC member	Feedback from the RAC Chair
PL	JANKOWSKA Agnieszka	Agnieszka JANKOWSKA was interviewed by the RAC Chair on 19 March 2024. She is currently working as a chief specialist at Department for Risk Assessment of Bureau for Chemical Substances in Poland, and she has been advisor to a member of RAC. Her expertise is mostly in human health toxicology as well as being familiar with REACH, Restrictions and CLP regulation. With regard her declaration of interest we discussed her occasional role in 3P EXPERT Sp. z o.o an external unit authorised by the Polish Ministry of Agriculture and Rural Development to prepare evaluations of dossiers for approval of active substances and authorisation of plant protection products on behalf of the Ministry; she confirmed she will not be active on the substances covered in those activities and she understood the obligations derived by the ECHA Conflict of Interest rules. She has confirmed her availability also in terms of time to be dedicated to the Committee. I therefore support her appointment by the MB.
IE	SMITH Jenny	Jenny SMITH was interviewed by the RAC Chair on 17 April 2024. She works for Chemicals Risk Management and Risk Assessment under REACH at the Health and Safety Authority of Ireland. Her area of expertise is in environmental chemistry and toxicology and fits the current needs of the Committee. Her declaration of interest does not raise any specific issues of concern. She has confirmed her availability also in terms of time to be dedicated to the Committee. I therefore support her appointment by the MB.
BG	KONDEVA-BURDINA Magdalena	Magdalena KONDEVA-BURDINA was interviewed by the RAC Chair on 13 May 2024. She works as a professor at Medical University of Sofia. Her declaration of interest does not raise any issues of concern, making her eligible for membership of the Committee. She was interviewed by the RAC Chair on 4 December 2023.
