# Amendment to authorisation – Advion Cockroach gel – NO-2015-0103

We refer to your application for major change to the authorisation of the biocidal product Advion Cockroach gel – NO-2015-0103, R4BP3 Case number BC-CK061175-46. The Norwegian Environment Agency hereby amends the authorisation.

## Background

According to Article 50(2) in Regulation (EU) No. 528/2012 concerning the making available on the market and use of biocidal products (the Biocidal Product Regulation, BPR), the Competent Authority shall decide whether a change of an authorised biocidal product can be accepted with regard to ensuring compliance with Article 19 or, where relevant, Article 25, and whether terms and conditions of the authorisation need to be amended. Procedures for amendments to a product authorisation are further described in Regulation (EU) No. 354/2013.

Regulation (EU) No. 528/2012 and Regulation (EU) No. 354/2013 are implemented in Norwegian law through the Norwegian Biocide Regulation of 18 April 2017 No. 480

The amendment to the authorisation of Advion Cockroach gel concerns label extension and user categories, and is classified as a major change, in accordance with the criteria laid down in Title 3 of the Annex to Regulation (EU) No. 354/2013.

#### **Evaluation**

According to the national restrictions, Norway do not have the professional user category for biocidal products in PT18, only trained professional and general public according to "Forskrift om skadedyrbekjempelse" (only available in Norwegian). A derogation from mutual recognition is therefore made for Advion Cockroach gel in accordance with Article 37 of the BPR, adjusting the terms and conditions of the Norwegian authorisation in accordance with the national policy. The derogation has been communicated to the applicant and agreed upon earlier in the evaluation process.



The evaluation of the Norwegian Environment Agency is that the sought amendment to the authorisation of the biocidal product Advion cockroach gel is in line with the conditions for granting an authorisation laid down in Article 19 of the BPR.

#### Decision

Subject to Articles 50 of the BPR, cf. § 1 of the Norwegian Biocide Regulation, the Norwegian Environment Agency accepts the proposed change(s) to Advion cockroach gel and amends the authorisation in conformity with the applied change(s).

No other change(s) than the above mentioned is accepted with this letter. Apart from the change(s) outlined above, the terms and conditions as stated in the authorisation letter dated 11.12.2019 apply.

The revised Summary of Product Characteristics (SPC) is uploaded to R4BP3.

#### Label

In cases where the changes concerned in this letter have any consequences for the content on, or the design of the label, you are kindly requested to submit an electronic copy of the revised label with the Norwegian authorisation number NO-2015-0103 to <a href="mailto:biocides@miljodir.no">biocides@miljodir.no</a> within three months from the date of this letter.

# Phase-out period of existing stocks, when relevant

In accordance with Article 52 of the BPR, when an authorisation is amended, the Competent Authority shall grant a period of grace for the making available on the market and use of existing stocks, except in cases where continued making available on the market or use of the biocidal product would constitute an unacceptable risk to human health, animal health or the environment.

The period of grace shall not exceed 180 days for the making available on the market and an additional maximum period of 180 days for the use of existing stocks of the biocidal products concerned, with effect from the date of this letter.

### **Appeal**

This decision can be appealed to the Ministry of Climate and Environment, in accordance with Article 28 of the Public Administration Act. The complaint must be submitted to the Norwegian Environment Agency within 3 weeks after receipt of this letter, in accordance with Article 29 of the Public Administration Act.
