



Transfers within the budget since last notification

In line with Article 26(1) of ECHA's Financial Regulation, the budget transfers carried out (by 25 May 2021) under the responsibility of the Executive Director since the last notification to the Management Board are listed hereunder:

a) 22 March 2021: Transfer within Environmental directives and international conventions (PIC, POPs, SCIP, DWD and 8th EAP) Title 1 – Staff expenditure.

As the budget lines for staff expenditure are provisional by nature and the initial budget needs are established based on the Establishment Plan, there is an inherent uncertainty in this planning (for example, related to the grades of entering into service, turnover and family allowances of the newcomers). To date, there has been a higher than anticipated need for additional external support (interims) and, in parallel, there were funds available in basic salaries for Temporary and Contract Agents. Therefore, a transfer between budget lines within Title 1 (as per the table below) was required.
