On an authorisation of the same biocidal product Free Active Spray

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **ACP Solutions BV** on 30th March 2024 concerning an authorisation of **Free Active Spray** according to *Commission Implementing Regulation (EU)* No 414/2013 of 6 May 2013 specifying a procedure for the authorisation of same biocidal products in accordance with Regulation (EU) No 528/2012 of the European Parliament and the Council (Regulation (EU) No 414/2013).

The reference product is **Insect Repellent Pump Spray IR3535 20%** (authorisation number - **LV/2017/MR/023**) authorised through mutual recognition in Latvia on 7th September 2017. Authorisation holder is **Merck KGaA**, Frankfurter Strasse 250, 64293, Darmstadt, Germany.

ACP Solutions BV submitted application for authorisation of a same biocidal product *Free Active Spray* according to Article 2 and 3(1) of the Regulation (EU) No 414/2013.

LEGMC accepted and agreed with proposed differences between *Free Active Spray* and *Insect Repellent Pump Spray IR3535 20%* that are the subject on an administrative change in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013).*

Therefore, in accordance with Article 5 of Regulation (EU) No 414/2013 LEGMC grants the authorisation of the same biocidal product *Free Active Spray*.

Additional trade name for Free Active Spray in Latvia is Free Tick.

The biocidal product *Free Active Spray* contains **20** % (w/w) of **ethyl 3-[N-acetyl-N-butyl] aminopropionate** (CAS No. 52304-36-6; EC No. 257-835-0) as active substance.

LEGMC assigns the authorisation number LV/2024/SB/003 for the biocidal product *Free Active Spray*.

The authorisation is valid until 16th May 2027.

The authorisation number shall be indicated on the label of the biocidal product.



The authorisation of *Free Lotion Plus* is granted on the following terms:

- Product type: 19 Repellents and attractants;
- Target organism mosquitoes (*Culicidae*) and ticks (*Ixodidae*);
- Users: general public;
- Product description: liquid;
- Product stability: shelf life 18 months.

The authorisation applies only to the same product *Free Active Spray* in the form, composition and packing according to the reference product *Insect Repellent Pump Spray IR3535 20%* for which the first authorisation is granted by reference Member State – Belgium.

The information on the label (and if applicable an enclosed instruction of use) of the *Free Active Spray* should be as it is indicated in the first authorisation for *Insect Repellent Pump Spray IR3535 20%*, considering Product Assessment Report, summary of Product Characteristics and proposed differences for same product.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

ACP Solutions BV as the authorisation holder shall inform LEGMC about any changes in accordance with *Regulation (EU) No 354/2013*.

Additionally, LEGMC would like to inform that ACP Solutions BV is fully responsible of the content of the biocidal product *Free Active Spray* as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask ACP Solutions BV to notify the above-mentioned information down to supply chain.
