**On an authorisation of the biocidal product family TEKNOS BLUESTAIN PRIMERS through mutual recognition in Latvia**

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Teknos A/S** on 12<sup>th</sup> October 2018 concerning an authorisation of **TEKNOS BLUESTAIN PRIMERS** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **TEKNOS BLUESTAIN PRIMERS** developed by the reference Member State – Denmark.

Therefore, in accordance with Article 34 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (regulation 528/2012) LEGMC authorises the **TEKNOS BLUESTAIN PRIMERS** on the basis of mutual recognition process.

The authorisation holder for **TEKNOS BLUESTAIN PRIMERS** in Latvia is:

**TEKNOS BLUESTAIN PRIMERS** contains active substance 3-iodoprop-2-yn-1-yl butylcarbamate (CAS No. 55406-53-6; EC No. 259-627-5) at the concentration range 0.294 – 0.600 %.

**The authorisation number is valid until 20<sup>th</sup> October 2031.**

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of **TEKNOS BLUESTAIN PRIMERS** through mutual recognition is granted on the following terms:

- Product type: 8 – Wood preservatives;
- Target organism – wood discolouring fungi;
- Users: professional and industrial;
- Product description: Ready-to-use liquid;
- Product stability: shelf life – 2 years;
- Field of use: indoor and outdoor;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to **TEKNOS BLUESTAIN PRIMERS** in the composition, form and packing material for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) shall be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *regulation 528/2012*,



- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,*
- all other relevant legislation shall be applied.

Teknos A/S as the authorisation holder shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation may be re-opened for review before the 20<sup>th</sup> October 2031.

Additionally, LEGMC would like to inform that Teknos A/S is fully responsible of the content of **TEKNOS BLUESTAIN PRIMERS** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Teknos A/S to notify the above mentioned information down to supply chain.
