# Acceptance of administrative change to the authorisation for Koppers Performance Chemicals Denmark ApS – Celcure M65 – NO-2019-0162

With reference to the notification dated 20 January 2023 for administrative changes to the authorisation for the biocidal product Celcure M65, R4BP 3 case number BC-MK083972-20.

### Decision

The Norwegian Environment Agency hereby accepts the notified administrative changes to the the product authorisation for Celcure M65 on the Norwegian market.

#### Terms and conditions for the change to the authorisation

The revised terms and conditions are described in the final Norwegian Summary Product Characteristic (SPC) attached to the R4BP3 asset case no. NO-0020344-0000. The terms and conditions as stated in the authorisation letter dated 1 March 2019 also apply.

The approval is given in accordance with Article 6(4) of Regulation (EU) No 354/2013, c.f. Article 50 of Regulation (EU) No 528/2012 (the Biocidal Products Regulation, BPR).



## Background

Regulation (EU) No 528/2012 and Regulation (EU) No 354/2013 are implemented in Norwegian law through the Norwegian Biocide Regulation of 18 April 2017 No 480.

The procedure for applications for administrative notifications to authorisations are set out in Article 6 of Regulation (EU) No 354/2013.

## The notification concerns

Koppers Performance Chemicals Denmark Aps has notified administrative changes to the authorisation of Celcure M65 on the Norwegian market. The notified changes concern transfer of national authorisation, as referred to in Section 1 of Title 1 to the Annex to Regulation (EU) No 354/2013 and change of manufacturer's address as referred to in Section 2 of Title 1 to the Annex to Regulation (EU) No 354/2013.
