On an authorisation of DELTASECT through mutual recognition

Latvian Environment, Geology and Meteorology Centre (LEGMC) is the Competent Authority for implementation of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*. On 14th August 2017 LEGMC received the application for the authorisation of **DELTASECT** through mutual recognition in sequence submitted by Sharda Europe B.V.B.A.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **DELTASECT** developed by the reference Member State – United Kingdom.

Therefore, in accordance with Article 33 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products LEGMC authorise the **DELTASECT** on the basis of mutual recognition process.

The authorisation holder for **DELTASECT** in Latvia is:

Sharda Cropchem España S.L.

DELTASECT contains 2.394 % (w/w) of *deltamethrin* (CAS No. 52918-63-5, EC No. 258-256-6) as active substance.

LEGMC assigns the authorisation number of DELTASECT through mutual recognition:

LV/2017/MR/026

The authorisation of DELTASECT through mutual recognition is valid until 30th March 2027 based on reference Member State – United Kingdom decision.

The authorisation number of **DELTASECT** through mutual recognition shall be indicated on the label of the biocidal product.

The authorisation of **DELTASECT** through mutual recognition is granted on the following terms:

- Product type: it is only authorised for use as a product type 18 – Insecticides, acaricides and other products to control arthropods – crawling insects including cockroach – Blattelle and ants – Hymenoptera: Formicidae;
- Users: professional and non-professional;

- Product description: suspension concentrate insecticide for use against crawling insects including cockroaches and ants by crack and crevice treatment;
- Product stability: shelf life 2 years;
- Use area: indoors use in/at private and public areas;
- Packaging size: packaging sizes and materials are: bottles made of HDPE or COEX containing 25, 50, 100, 500, 1000 and 5000 mL for professional use and bottles made of HDPE or COEX containing 25, 50, 100 and 500 mL for non-professional use.

The authorisation through mutual recognition applies only to the biocidal product **DELTASECT** in the composition, form and packing material for which the first authorisation is granted by reference Member State to **DELTASECT**.

The information on the label (and if applicable an enclosed instruction of use) of the **DELTASECT** should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*,
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006*,
- all other relevant legislation shall be applied.

Sharda Cropchem España S.L. as the authorisation holder shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council*.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **DELTASECT** through mutual recognition may be re-opened for review before the 30th March 2027.

Additionally LEGMC would like to inform that Sharda Cropchem España S.L. is fully responsible of the content of the biocidal product **DELTASECT** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Sharda Cropchem España S.L. to notify the above mentioned information down to supply chain.
