## On an authorisation of the same biocidal product BRODY 2.5 BLOCK

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Kollant S.r.l.** on 20<sup>th</sup> January 2023 concerning an authorisation of **BRODY 2.5 BLOCK** according to *Commission Implementing Regulation (EU) No 414/2013 of 6 May 2013 specifying a procedure for the authorisation of same biocidal products in accordance with Regulation (EU) No 528/2012 of the European Parliament and the Council (Regulation (EU) No 414/2013).* 

The reference product is *ACTIBLOCK-BROD* (authorisation number - LV/2023/MR/005) authorised through mutual recognition in Latvia on 5<sup>th</sup> April, 2023. Authorisation holder is **Activa s.r.l.**, Via Feltre, 32, 20132, Milano, Italy.

Kollant S.r.l. submitted application for authorisation of a same biocidal product BRODY 2.5 BLOCK according to Article 2 of the Regulation (EU) No 414/2013.

LEGMC accepted and agreed with proposed differences between BRODY 2.5 BLOCK and ACTIBLOCK-BROD that is the subject on an administrative changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013).

Therefore, in accordance with Article 5 of Regulation (EU) No 414/2013 LEGMC grants the authorisation of the same biocidal product to the BRODY 2.5 BLOCK.

**BRODY 2.5 BLOCK** contains 0.0025 % (w/w) of 3-[(lRS,3RS;1RS,3SR)-3-(4'-bromobiphenyl-4-yl)-1,2,3,4-tetrahydro-1-naphthyll-4-hydroxycoumarin (**Brodifacoum**) (CAS No. 56073-10-0; EC No. 259-980-5) as active substance.

LEGMC assigns the authorisation number for same biocidal product BRODY 2.5 BLOCK: LV/2023/SB/004

The authorisation of BRODY 2.5 BLOCK is valid until 1st July 2024.

The authorisation number of **BRODY 2.5 BLOCK** shall be indicated on the label of the biocidal product.



The authorisation of **BRODY 2.5 BLOCK** is granted on the following terms:

- Product type: 14 rodenticides;
- Target organism house mouse (Mus musculus), brown rat (Rattus norvegicus);
- Users: professionals and general public;
- Use area: indoor and outdoor around buildings;
- Product description: bait (ready for use);
- Product stability: shelf life 2 years;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation applies only to the same product BRODY 2.5 BLOCK in the composition, form and packing according to the reference product ACTIBLOCK-BROD for which the first authorisation is granted by reference Member State – Italy.

The information on the label (and if applicable an enclosed instruction of use) of the BRODY 2.5 BLOCK should be as it is indicated in the first authorisation for ACTIBLOCK-BROD, taking into account Product Assessment Report, summary of Product Characteristics and proposed differences for same product.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012 of the European Parliament and of the Council
  of 22 May 2012 concerning the making available on the market and use of biocidal
  products,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16
  December 2008 on classification, labelling and packaging of the substances and mixtures,
  amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending
  Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

Kollant S.r.l. as the authorisation holder shall inform LEGMC about any changes in accordance with *Regulation (EU) No 354/2013*.

Additionally LEGMC would like to inform that Kollant S.r.l. is fully responsible of the content of the biocidal product **BRODY 2.5 BLOCK** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Kollant S.r.l. to notify the above mentioned information down to supply chain.
