On minor changes of the national authorisation of the biocidal product family *Hydrochloric Acid Family A*

Latvian Environment, Geology and Meteorology Centre (LEGMC) received an application submitted by **Reckitt Benckiser (Brands) Ltd** on 27th October 2017 for minor changes via Register for Biocidal product (Case No. BC-VX034813-00) in accordance with Article 7 of *Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council* for the biocidal product **family *Hydrochloric Acid Family A*** with authorisation number **LV/16/NA/01**.

LEGMC as the Competent Authority have developed Product Assessment Report and Summary of Product Characteristics for biocidal product family ***Hydrochloric Acid Family A*** based on application for minor changes.

LEGMC has agreed with the following proposed minor changes:

- Addition of four new formulations into biocidal product family;
